

However, people are getting certificates in makeup artistry and practicing. HLPAE could add makeup artistry to one of the cosmetology licenses (i.e. esthetician) to attract more students. There was also a discussion regarding the organization of cosmetology instruction. Currently, multiple instructors are given part time hours that require them to leave their students and clients in the middle of a lesson. There are also too many students for one instructor to manage at one time. Suggestion – create externships for previous students who did well in the program.
